co.mpanion offers a new model where you can be a shareholder, receive skilled support, and retain your practice autonomy

Owning an independent stand-alone practice can be satisfying but often comes at too big a price. It can be lonely and difficult, and the demands can lead to burnout and disenchantment with the profession. An historic lack of support is contributing to our professionals leaving to work in the wider industry in search of more sustainable lifestyles, or emigrating in search of different opportunities.

Working for a vet or corporate often comes with the loss of shareholding, personal drive and voice – and ultimately

leaves professionals feeling like just a number. It takes away clinical initiative and leadership autonomy and can lead to distrust and resentment.

The veterinary profession has always made clinicians choose between either total independence and isolation OR total lack of ownership and disempowerment. Never before have clinicians had the option of being shareholders while receiving skilled support AND retaining practice autonomy.

The co.mpanion model provides clinical owners with 'More success; less time and stress' by offering:

- **Shareholding opportunities:** all clinicians (vets and para-vets) have the opportunity to be shareholders in their own practice (1-5 active clinicians owning the majority of each practice) which has associated financial and self-worth benefits
- **Administrative support and delivery:** co.mpanion operations (co.op) supports shareholders and practices with burdensome admin and regulatory compliance which stops decision fatigue and prevents burnout
- **Autonomy in independent vet practices:** autonomy means the right to make your own decisions which gives shareholders the space to be strategic leaders of their practice
- **A clinical co.mmununity:** individual clinicians are no longer isolated but rather are part of a clinical co.mmununity of professional colleagues that offers clinical and personal support and advice. As a clinical co.mmununity there is an opportunity to work towards and build standards of care we can be proud of and stand behind as professionals
- **Skills to grow and develop personally:** vet and para-vet shareholders are upskilled in business and leadership which helps ensure good decisions are made that have a lasting impact in their practices
- **The financial strength of a network:** practices are part of a larger network which offers buying power, operational efficiency and brand recognition

The model is designed for clinicians who want control of their professional lives, but do not necessarily want to endure all the burdens that owning a practice can entail. It's not for those who need or want control over every decision, neither will it work for those who merely want to clock in and clock out. The idea of being a shareholder means you really care about how the network is doing and are not just there to come in and do a job. If you struggle to ask for help or have a tough time taking others' opinions onboard, then this model may not be the best fit for you.

Open, transparent and straightforward co.mmunication is essential and a strong part of who we are as a model.

The model is for those professionals who want to deliver exceptional clinical care and are able to share in one another's successes.

Our next step is to develop further and grow our network with a set of early adopter veterinary professionals and practices.
